YOUR RESPONSIBILITIES:

EHS Engineer reports to EHS Manager and mainly responsible for:

- Assist to ensure all EHS activities compliance with legal laws in PRC and Corporate standard. Achieve and maintain high Safety, Environment and Occupational Health goals: Zero IRR, Zero Occupational Disease, Zero government fine, and Zero Environmental Accident/release.

Essential Functions:

- Assist to set up, maintain and implement Safety, Health & Environment policies, procedures and management program to meet all kinds of requirements from government and Pulcra management team.
- Assist to Build up and implement an EHS management and working culture, and implements ISO 14001 environment requirements and special work permits.
- Liaise with authorities and legal experts, ensure company to be compliant with all local & National regulations and laws on EHS, timely remind company management of EHS risks and non-compliance issues and make effective correction proposal.
- Review the design & process and Support MOC (Management Of Change) from all Dept. on EHS matters, to achieve continuous improvement.
- Review all necessary training requirements to obtain the training information and arrange the related training and keep the record.
- Responsible for ERP, security and site EHS management.
- Be responsible for managing the disposal, storage, and treatment of hazardous waste to reduce the risk and cost.
- Develop and implement a chemical approval program. Conduct and monitor chemical management system.
- Investigate environmental and work-related injuries/illnesses to identify causes and corrective/preventive actions. Track to closure all identified corrective and preventive actions.
- Set up, organize, coordinate and evaluate EHS activities, e.g. projects EHS related activities, PPE management, firefighting, Emergency Response Drill, Chemicals leakage, Epidemic prevention and control, First Aid, incidents etc.
- Responsible for all EHS test job and Occupational check on time to meet EHS requirements of laws and regulations.
- Supervise and achieve all safety-related licenses. Coordinate EHS related issues with neighbors, landlords, and respond to regulatory requirements of official Wechat groups.
- Make monthly report and summary: monthly report of energy, water, industrial output value and other monthly report, organize monthly EHS meeting, put forward suggestions for continuous improvement of EHS management, and supervise the implementation of EHS corrective and preventive measures.
- Daily safety supervision and EHS management in new construction site. Set up new EHS rules, policies and systems in new site.
- Complete assignments delegated by the superior and Management Team.
